NOTICE OF PUBLIC HEARING

A public hearing will be held at 8:00 P.M. on August 18, 1986 at the Wright City Fire House, at which citizens may be heard on the property tax rates proposed to be set by the Wright City Fire Protection District, a political subdivision. The tax rates shall be set to produce the revenues which the budget for the fiscal year beginning January 1, 1986 shows to be required from the property tax. Each tax rate is determined by dividing the amount of revenue required by the current assessed valuation. The result is multiplied by 100 so the tax rate will be expressed in cents per \$100 valuation.
